Entrance Hall

With radiators and storage cupboard. Stairs leading to first floor landing. Door lead to rear garden. Doors leading to:

Living Room

With radiators, open fire and windows to both front and rear aspect.

Dining Room

With radiators, open fire (not in use) and storage cupboard. Door leading to:

Kitchen

With matching base and head units, sink, cooker, dishwasher, radiator and window to side aspect. Door leading to:

Utility Area

With kitchen units and sink. Stairs leading to Bedroom 4. Door leading to rear garden. Door leading to:

Store Room

With plumbing for washing machine and windows to both side and rear aspect.

Shower Room

With WC, hand wash basin, shower and windows to side and rear aspect.

First Floor Landing

With radiator, window to rear aspect and doors leading to:

Bedroom 1

With radiators and windows to both front and side aspect.

Bedroom 2

With radiators and window to front aspect.

Bedroom 3

With radiator, window to side aspect and cupboard housing the immersion heater.

Bedroom 4

With radiators and windows to side aspect.

Bathroom

With WC, hand wash basin, bath with shower over and window to rear aspect.

Outside

The property is benefitted from a gated driveway with parking for several cars. There is a large front garden laid to lawn with a courtyard area to the rear. There is an outbuilding divided into 3 sections, garage, workshop and stables.

Services

The Tenant(s) will be responsible for payment of water, oil, drainage, electricity and council tax as applicable. Council Tax Band - F.

Rent

Rent is payable monthly in advance on the first day of each calendar month.

Deposit

The deposit is calculated as an equivalent of 5 weeks' rent.

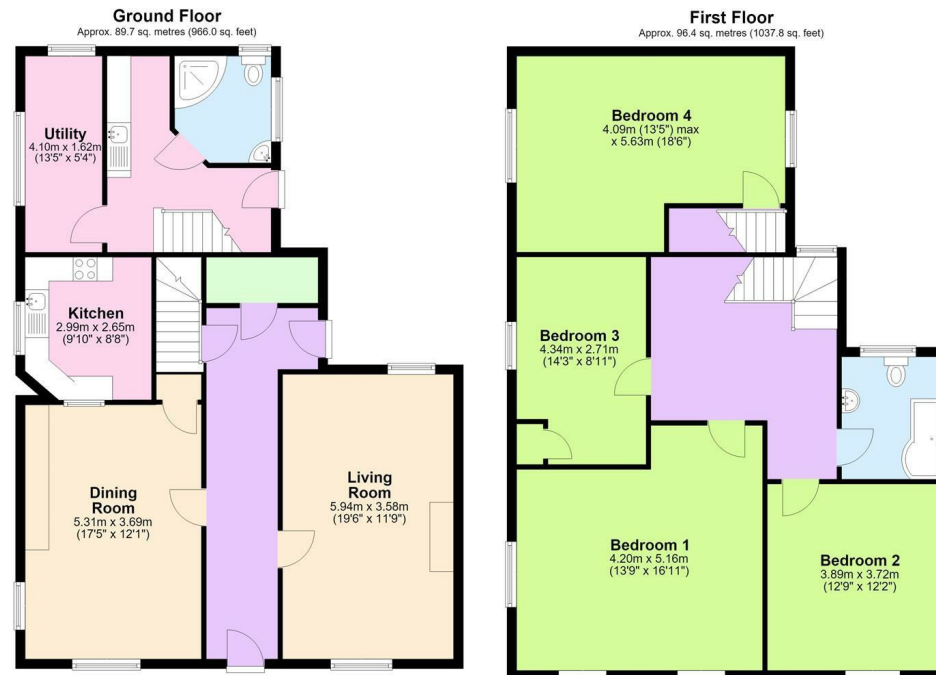
